Pooja is still continuing to be the founder trustee of the trust of Planet Hope Asia Foundation along with the incoming trustees mentioned above to form the Board of Trustees.

Whereas ever since from the Mr. Saurav Chettri and Ms. Maria Roshini Sunder Raj who were functioning as the Trustees expressed their inability to continue in the Trust, the continuing Trustee, Ms. P Pooja has associated herself with the affairs of the trust and at the instance and knowledge of the then existing trustees she has formerly inducted the aforesaid persons as Trustees in the Meeting of the Trustees as per the resolution dated 31st August, 2021 passed by the Trustees.

Whereas the continuing Trustee, Ms. P Pooja had also accepted and recorded the resignation of Ms. Maria Roshini Sunder Raj, one of the Founder Trustees on 31st August 2021 and the resignation of the Chief Executive Trustee Mr. Saurav Chettri in a resolution dated 29th September 2021, all of which was registered on 26th November, 2021 and accordingly a Reconstitution trust Deed is duly registered as Document No.SHV-4-00356/2021-22, of Book-4, stored in CD No.SHVD992, registered before the office of the sub-registrar, Shivajinagara(Shivajinagara) Bangalore and accordingly new trustees were inducted and the said trust is functioning till this day.

Whereas one of the trustee Ms. Kavya K V had expressed to resign the said trust And whereas the continuing Trustee, Ms. P Pooja has accepted the resignation of Ms. Kavya K V on 11th November 2023, and the same is taken on record and being effected in this Reconstitution Deed of the Trust All other trustees continue to hold office without any change.
